Bridal Parties: \$100 for the bride and any additional clients are \$77.00+/person if offsite and \$67.00+ if at Blush Beauty Bar LLC.

- D) Travel: If event location is offsite there will be a fee of \$75.00 that will be applied per stylist needed. *\*additional cost if it is outside a 60 mile radius\**

## 5. CANCELLATION:

In the event the client cancels, client will lose retainer made to artist. Upon cancellation, client will have no further obligations to the artist.

This agreement shall be signed and dated by both parties to secure said date and event. "Your date is NOT secure without paid retainer."
